Infection Preventionist Module in ECS

With the current COVID-19 crisis & the new mandate that took effect Nov. 28, 2019, requiring facilities to have at least one infection preventionist on staff, ECS is developing more tools for infection prevention and the handling of outbreaks at facilities. Part of the Phase 3 Requirements of Participation for Nursing Homes that came out in November 2016 from the Centers for

Medicare and Medicaid Services (CMS), this mandate requires LTC facilities to have a designated and specially trained infection preventionist to run a comprehensive infection prevention and control program. In last month's webinar we gave you a sneak peek of the new Infection Preventionist Module and now it is ready and available to clients!

It will include new topics underneath the Human Resources tab in your system for Employee Health & Immunizations, along with some new words to be transferred into your existing Employee Information topic. If you do not have a Human Resources tab OR if you have already received Employee Health, then you will be able to indicate that on our Smartsheet form that we are asking any client wanting to receive this module to complete. You will also receive the new Infection Preventionist Access screen, including the Gastroenteritis and Respiratory Surveillance and Outbreak Summary topics, along with an Infection Prevention & Control (IPC) Risk Assessment, IPC Practice Failures & Inter-facility IC Transfer topics. Accompanying these new topics, you will also receive roughly twenty additional reports & graphs that will provide instruction, raw data, and summary reports.

St. Clare Meadows Care Center

Diane Hill from St. Clare Meadows Care Center located in Baraboo, Wisconsin writes, "[We are] a skilled nursing facility with 102 beds and a CBRF with 16 beds attached. Both the skilled nursing facility and the CBRF use ECS by American Data. We use all components from documentation to electronic MAR/TAR.
