# Coming Soon: AP & GL Enhancements in ECS10

I am Kara McDonald and have worked at American Data for over 20 years in the ECS Financial Support/Training Department. As some of our clients may know, my capacity under the leadership of John Ederer, our President, has been Supervisor of that department. A few

years ago, John assigned me to lead the programming/development for the Financial part of ECS. Because some of our clients were using version 9 of ECS and others using ECS10, we had to program and test in both versions. That is double the work and time investment! Currently, the majority of clients use ECS10, and therefore all future government requirements and enhancements for ECS will only be done in ECS10.

Now I can lead financial development on projects to not only enhance Accounts Receivable (AR) but also improve/add General Ledger (GL) and Accounts Payable (AP). I look forward to this endeavor! While ECS's Accounts Receivable can link to QuickBooks and Great Plains, I feel our clients would be better served by having all three financial modules (AR, AP & GL) in one robust system. We have already started work on this project using client suggestions, consultants, and the team here at American Data. We will continue to add enhancements to Accounts Receivable to include new programming in auto-adjustments, aging reports, journals, financial forms, and electronic billing to name a few.

Though American Data's President and Founder, John Ederer, is in the office every day, I am thankful for his trust and confidence in my capabilities to head up this project.
