Move Forward with the ECS10 Conversion Process.

Administrators and DON's: Look for our informational mailer to arrive within the next week.

October 1st, 20**19** has come and gone, and American Data successfully endured one of the biggest changes in LTC operations in history with the PDPM regulations. For us, these regulatory changes were immense from a programming and testing point of view. Because of

all the variables in an MDS that are dependent on the individual patient situations, the testing was not 100% upon release. This resulted in several updates. I would like to personally thank all of you for your patience as we went through that process.

Our challenge was doubled by the fact that we had to do the programming and testing in both Version 9 and ECS10 as we have clients using one or the other version. This is not only more expensive; it also divides our personnel resources which could be better used in programming and testing in just one version. Looking ahead to October 1st, 20**20**, once again the government is forcing change onto the industry. It is our plan to program these new requirements into both Version 9 and ECS10, as well as add even more enhancements into ECS10.

As an encouragement for clients to move to ECS10, my staff has put together this booklet to show what extra enhancements are found only in ECS10. It is also intended for those clients who have already moved to ECS10 to use the enhancements they have in their current system. In summary, it will be better for all clients when all our clients are on ECS10.

Something to think about: with ECS Version 9 and ECS10, whether your facility self-hosts or hosts through American Data, the facility or organization has its own server(s) where the access to the server(s) can be controlled by the facility or organization. This is important in today's aggressive compliance monitoring environment. Version 9 is client/server-based and ECS10 is a combination of client/server AND browser-based, thus allowing the facility or organization to have complete server control of who (including surveyors) has access to your clinical and financial records at any given time.

We know that our clients believe in the flexibility of ECS. Every facility is different and with this flexibility, the focus can remain on what is needed to best care for the resident, rather than a focus just on meeting the minimal requirements of regulation. To that end, we stay committed to our clients in 2020 and years beyond. We thank you for your dedication to quality patient care and your loyalty to American Data and its dedicated staff.
