ECS Updates

Trauma Informed Care in ECS

As November 28th is fast approaching, so is **Phase 3** of CMS' Requirements of Participation (RoP). There are seven specific requirements for facilities to focus on in order to be in compliance. One of these specific requirements is in relation to **Trauma-Informed Care/Behavioral Health Services**. The facility must ensure that residents who are trauma survivors receive care which properly accounts for their experiences and preferences to eliminate or mitigate re-traumatization.

CMS has not provided set guidelines for how this care must be administered or which types of assessment tools should be utilized to screen for trauma. After research and discussions with our clients, we have decided to build the **Life Events Checklist** and the **PTSD Checklist – Civilian Version** into ECS. If your facility is interested in receiving these tools, please send an **email** to <u>clinical@american-data.com</u> with your facility **name**, the **section** of your system you'd like the new topics added into, a **contact** person who can be reached for when we complete the setups, as well as your approval of an hour of **billable time**. Currently our billable rates are \$90/hour for remote work.

PDPM REMINDERS

PDPM for Accounts Receivable Clients

ECS is prepared for billing October dates of service under PDPM and have received word of accepted claims already! Prior to doing your October billing here are a few reminders:

- Remember to add your PDPM HIPPS Codes rates and update your Incentive Payment Multiplier prior to calculating October dates of service.
- For Traditional Medicare (A) residents you should not be seeing Federal RUGs on your calendars. If you do, you need to chart the End Federal RUGs as of 10/01/2019 on those residents. All group totals should balance as normal.
- You should see PDPM HIPPS Codes on your calendars and on your PDPM Analyzer for all Traditional Medicare (A) days in October. Check with your MDS Coordinator if there are PDPM HIPPS Codes you expect to see that are missing.
- Your Medicare Replacement residents should also have PDPM HIPPS Codes for October as

long as your contracts are reimbursing based on PDPM HIPPS Codes. We do have some Med Replacement issues that we are planning to release a fix for asap.

- The next release will include a fix for the Medicare (A) calculating screen missing the last date only if the resident's Discharge Date is the day following their last covered day.
- We will soon be releasing an enhancement to allow you to generate default HIPPS Codes for billing situations when necessary.


