Interface Setups in ECS

There are many different vendors a facility may work with, such as therapy, lab, pharmacy, radiology, hospitals, and state health exchanges. An interface helps reduce faxing, phone calls, and double documenting in multiple systems. American Data has well established interfaces with many vendors, but each client's database is unique, so we



customize each interface we setup. The unique design of ECS that allows clients to mold their EMR system to their particular health care goals and procedures to achieve those goals, does make it more challenging when it comes to interfaces. That same unique design of being able to customize the user experience is also a security feature of ECS in that from one facility to the next things may be different so that the facility can control when, where, why, how outside people have access to the medical records of your facility. Because every setup of an interface is unique to the facility, we only charge for an interface for those facilities which chose to have a desired interface rather than bury the cost in an unrelated cost to all facilities.

(admission, discharge, transfer) interface. This type of interface is similar from facility to facility and vendor to vendor, but where that information is documented in ECS can vary. This might mean triggering an interface message off the Admission Date word in the Face Sheet>Status topic, or possibly an Admission Date word somewhere in nurse charting. Variations in how charting is done, is one of the reasons why each ADT interface we setup is unique to each individual client's database.

Another common interface is lab and radiology results. In this case, ECS receives results from another vendor which are imported into ECS. Although most vendors put the same data in the same fields in the message, there can be significant differences. Those results are typically imported into a nurse charting topic, which can vary significantly from one client to another.

Also, if charting is done differently between the different sites and services within a client's database (SNF, AL, IL, etc.), all of these situations must be taken into account when setting up the interface. Customization can be done to modify how certain elements are presented in ECS, which allows us to tailor an interface according to the operation of the facility so that the facility can control their own workflows that work best for them.

Once we have an established interface with another vendor, in many cases the interface setup is similar from one client to another. We try to create "standard" setups whenever possible to help reduce setup time and allow us to get an interface live as soon as possible. ECS users are used to a system allowing for customization and flexibility to fit their individual facility needs. This same ability extends into the interface options we provide, allowing communication with other vendors to function in the best way for each of our clients. Significant, detailed customization cannot be done with fixed field, cookie cutter systems.

Medi-Span Announces GPI Changes

According to a technical bulletin sent from Medi-Span, several drugs are being re-categorized with a new Generic Product Identifier (GPI) to provide a positive impact to the drug formulary. GPIs are utilized to assist in matching a medication if sent via a Script pharmacy interface, as well as when completing drug contraindications. If your facility does not utilize a Script pharmacy interface, drug contraindications, or have any orders containing a medication in the list provided, then no changes are needed. However, if you do look through the table and find any of those medications on your resident records, these will need to be updated so they include the new GPI. Although there are 195 medications on the list, it appears many are not commonly used. So we are anticipating minimal changes needed, if any.

The GPIs are being updated as of the file pushed out on April 7, 2021. Our clients can begin to re-write any affected orders on April 12, 2021. Orders will need to be discontinued and

entered from scratch to pick up the correct GPI.

Please reference the <u>Medi-Span Spring 2021 GPI Changes</u> spreadsheet or click the "Get Document" button below for the list of medications being changed. In this spreadsheet, we list the old GPI, new GPI, and drug name. Keep in mind, this will only affect medications written **prior to April 7, 2021**. If any medications on the list are written after this date, they will automatically have the updated GPI attached.

ECS AR - Conversion Factor Change

Since we sent the ECS AR Year End email, CMS has recalculated the Medicare Physician Fee Schedule rates. The Conversion Factor is used in calculating the MPPR (Multiple Procedure Payment

Reduction) on your Medicare (B) calculations. In our Year End email, we reported the new Conversion Factor would be 32.4085 (32.41). The new/corrected rate for 2021 should instead be 34.8931. Please update your Charge Master tasks, replacing what you have entered with the **new 34.8931 effective 01/01/2021** prior to calculating and posting Medicare (B) for January 2021.


