#### **GAD-7 Anxiety Scale**

Anxiety is an ever-increasing issue in nearly every demographic. To help our facilities to better identify, document, and effectively manage anxiety among their residents, we now have the GAD-7 Generalized Anxiety Disorder Assessment built in. This assessment is included in New Nursing Module installs and can also be purchased separately, regardless of which module your facility uses.

#### **Suicide Risk Screening**

ECS has added new tools to address Suicide Risk among residents. First are the Suicide Risk Screening and Brief Suicide Safety Assessment from the National Institute of Mental Health's ASQ Toolkit. Secondly, we have added the P4 Suicidality Screener. This is an additional 4 questions that accompany the PHQ-9 and are asked when a resident responds in the affirmative to having thoughts that they would be better off dead, or of hurting themselves in some way.





#### ECS now has a dedicated access screen for Restorative Aide

Restorative Aides can now view assignments, document minutes, and report any concerns to nursing staff all in one dedicated location. Users who work as both CNAs and Restorative Aides can toggle back and forth easily and will also enjoy a new Assignment Sheet specific to restorative users, allowing them to efficiently plan their day. These users can also quickly document any necessary equipment repair or toileting that took place while they were with the resident.


