

October 2023 MDS and Documentation Changes

What Changes Are Coming?

SPADEs - Standardize Patient Assessment Data Elements

- The Improving Medicare Post -Acute Care Transformation Act of 2014 (IMPACT Act) required CMS to develop, implement, and maintain these standardized data elements for post-acute care settings, such as long-term care and skilled nursing facilities.
- The data which is gathered is in 6 areas:
 - o Ethnicity
 - o Race
 - o Language
 - o Transportation
 - o Health Literacy
 - o Social Isolation
- Ethnicity A1005 and Race A1010
 - o These items have been added to section "A" of the MDS
 - o They replace A1000 and expand the possible responses.
 - o Continue to document these in ECS in Face Sheet > Personal Information
- Language A1110A/A1110B
 - o New item IDs assigned, but documentation is unchanged.
 - o Continue to document these in ECS in Face Sheet > Personal Information
- Transportation A1250
 - o Document in the new "Discharge Goals/Care Conference" topic, located in the Department Notes section of ECS.
- Health Literacy B1300
 - o Document in the new "Discharge Goals/Care Conference" topic, located in the Department Notes section of ECS.
- Social Isolation D0700
 - o New item accompanying the Mood/PHQ assessment on the MDS
 - o Document in the Mood/PHQ assessment in ECS.

Changes to MDS Items

Section A

- Entered From A1805 and Discharge Status A2105
 - o New items to expand upon and replace A1800/A2100
 - o Continue to document these in the Face Sheet > Status topic



- Provision of Current Reconciled Medication List to Subsequent Provider at Discharge A2121
 - New item added to meet requirements of SNF Quality Reporting program
 Transfer of Health Information Measures
 - o Document in the Nursing > LOA/Rm Change/DC/Transfer topic
- Provision of Current Reconciled Medication List to Resident at Discharge A2123
 - New item added to meet requirements of SNF Quality Reporting program
 Transfer of Health Information Measures
 - o Document in the Nursing > LOA/Rm Change/DC/Transfer topic

Section D

- Resident Mood Interview D0150 to D0600
 - o Interview questions remain the same, however, the way they are completed has changed:
 - For states with OSA: Continue to complete the mood assessment as it is currently. These items did not change on the OSA.
 - For states without OSA: This assessment is now abbreviated to only items A and B, if neither of those responses is a 2 or 3.
 - Continue to document this in the Assessments > PHQ 2 to 9 topic.

Section G

- ADLs All Section G items
 - o These items have been removed from PPS and OBRA assessments.
 - o There are 4 ADLs that remain on the OSA assessment type
 - Bed Mobility
 - Transfers
 - Eating
 - Toilet Use
 - These will be documented in new ADL topics in the CNA section for states which require OSA assessments.

Section GG

- Functional limitation in Range of Motion GG0115, Mobility Devices GG0120
 - o These items have been moved from section "G" to "GG" with no changes to the items themselves.
 - o Both are documented in the Nursing > NH Admission Note Topic
- Self-Care GG0130, Mobility GG0170
 - o There are 2 new items here and several others have been rearranged.
 - Tub/Shower Transfer
 - Personal Hygiene
 - The Interim section has been expanded and renamed OBRA/Interim.
 This section is now completed for all IPA and non-admission OBRA assessments. Continue to document this information in the Functional



Abilities or CNA Self-Care, Transfer, and Mobility topics. It will be pulled to the MDS based on the type of assessment and lookback period.

- o Nurses and Therapists will document in the new Assessments > Functional Ability/Goals (GGv4) topic.
 - The MDS inputs have been enhanced to work with the new lookback periods. Therefore, separate sets of words are no longer needed for admission, interim, and discharge sections in this topic.
 - CNAs also have new topics for Self-Care, Transfers, and Mobility, which are separate for each shift.
 - CNA topics do not contain the following items, and they are only found in the nursing assessment for Functional Abilities:
 - o Car transfer
 - o Walking 10 feet on an uneven surface
 - o 1 step (curb)
 - o 4 steps
 - o 12 steps
 - o Picking up object
 - Bathing GG0130E, and Tub/Shower Transfer GG0130FF
 - o These items are now in a separate Bathing topic for CNAs
 - Section GG MDS inputs now include information from both nursing/therapy and CNA topics. A formula for "most used" is applied and ECS will highlight the appropriate response when the collect feature is used. The MDS coordinator may click on the item number while completing the assessment to review the documentation.

Section J

- Pain Frequency J0410
 - New Item Number has been assigned, but the item itself and documentation is unchanged.
- Pain Effect on Sleep J0510
 - o Responses updated from Yes/No to more specific frequency options.
 - o Continue to document in Assessments > Pain
 - o Cue cards have been added to the pain assessment topic in ECS for the Verbal and 0-10 pain scales.
- Pain Interference with Therapy Activities J0520
 - o Document in Assessments > Pain
- Pain Interference with Day-to-Day Activities J0530
 - o Responses updated from Yes/No to more specific frequency options.
 - o Continue to document in Assessments > Pain

Section K

• Nutritional Approaches - K0520



- o The question remains the same, with new time frames added for "On Admission" and "At Discharge."
- o Continue to document in the Department Notes > Dietary Assessment topic.

Section N

- High-Risk Drug Classes: Use and Indication
 - o Two new drug classes added. These will pull from sign tasks as the previously existing classes do.
 - Antiplatelet
 - Hypoglycemic (including insulin)
 - o The MDS nurse can review medication orders to verify indications by clicking on the item number while completing the MDS.

Section O

- Special Treatments, Procedures, and Programs
 - o Several new categories and sub-categories added, as well as an option for "None of the above."
 - Document these in the new Department Notes > Care Conference/Discharge Goals topic.

Section Q:

- Participation in Assessment and Goal Setting Q0110
 - o These are now checkboxes and more than one can be chosen.
 - o Document in the Department Notes > Care Conference/Discharge Goals Topic.
- Has a referral been made to the Local Contact Agency (LCA) Q0610, Reason Referral to Local Contact Agency (LCA) Not Made - Q0620
 - o Item made more specific
 - o Document in the Department Notes > Care Conference/Discharge Goals Topic.

Changes to RAI Manual/Coding

• In addition to the above item changes, CMS has made a multitude of changes to throughout the manual. Please utilize the RAI manual and other resources available on the CMS website for education and training regarding these changes.
