- "Current Treatments" has also been removed and replaced with "Special Treatments/Procedures on Admission." The new treatments feature an expanded list of options which match the updated MDS items in section O (O0110).
- In the Prior Surgeries section, "involving male/female organs" has been changed to "involving genital systems."

New Documentation Topics

The following topics have been added to your ECS database and may replace existing topics. If an existing topic is replaced, the existing topic will be labeled "legacy" and the new topic will be set

up to display in the same tasks and reports. Also, documentation from the old topic will be displayed in the defined review area at the bottom of the screen when documenting.

Functional Abilities and Goals (GG) (Nursing/Therapy)

- Note: Nursing and Therapy will be sharing a single Functional Abilities and Goals topic.
- A new Functional Abilities and Goals topic has been added. This is called "Funct Abilities/Goals (GGv4)" and is in the "Assessments" section, or "Nurse Charting," if you don't have the New Nursing Module.
- The new topic works a bit differently than the old assessment: Rather than duplicating the assessment items for "Admission," "Discharge," and "Interim," the new topic has one set of words for all assessment types. These words are then pulled to the assessment based on the admission date and which items are open in section GG.
- There are instructional words are the beginning of each section to assist users in completing the correct portions of the assessment.
 - Complete for all residents This is the first section of the assessment and should be completed for all residents each time the assessment is assigned.
 - Continue to Skilled ADL Performance if first or last 3 days of stay This follows
 "Wheel 150'" and signals the end of the interim portion of the assessment.

Users can stop and sign the assessment here if it is neither the first nor the last 3 days of the resident's stay. Otherwise, the "Skilled ADL Performance" section should be completed.

- Continue to discharge goals if assessing day 1-3 of a skilled stay This follows 0 "Picking up object," and signals the end of the Skilled ADL Performance section. Users can stop and sign the assessment here unless the resident's payer is Medicare A and it is day 1-3 of their stay. Otherwise, at least one discharge goal should be assigned.

- o ^ Skip to Skilled Items Skilled items include car transfer, walking 10' on an uneven surface, steps, and picking up object. These items are not included in the CNA documentation, as nursing judgement may be required to determine if it is safe to attempt them. If your facility has GG documented by CNAs, it may still be necessary for nurses to complete this section of the assessment.

Discharge Goal/Care Conference (Q)

- A new topic has been designed to replace the previously used Discharge Planning (Q) and Care Conference topics. The new topic contains elements from both previous topics to provide more streamlined documentation of care conferences where residents/family/significant others participate in the assessment and goal setting for the resident.
- This topic houses documentation related to several of the new MDS items as well as the existing documentation for section (Q):
 - Lack of Transportation (A1250)
 - Provision of current reconciled medication list to resident (A2105)
 - o Provision of current reconciled medication list to provider (A2121)
 - o Health Literacy (B1300)
 - o Active Participants in the Assessment Process (Q0110)
 - Updated verbiage for Resident's Overall Goal (Q0310A)
 - Expanded options for Information source for overall goal (Q0310B) and desire to be asked about leaving the facility (Q0500C)
 - Updated verbiage for Resident's desire to be asked about leaving the facility (Q0500B)
 - o Local Contact Agency referral information (Q0500)
 - Special Treatments or Procedures while a resident and at discharge (O0110)

CNA Documentation Topics and Access Screens

- Each facility will be getting new topics for CNA documentation of section GG items (GG0130 & GG0170), as well as separate bathing topics, and a new ADL topic for section G if applicable.
- CNA Access screens will be updated to reflect changes to the documentation topics:
 - New buttons for Bathing, Self-Care, Mobility, Transfers, and ADLs(If applicable) will be added to the access screens.
 - o Buttons for retired and legacy topics will be removed.



- Note: For setups completed prior to 10/01/2023, the ADL buttons will remain, and the new Functional Ability buttons (Self-Care, Mobility, & Transfers) will be added to the screen so that ADLs can still be completed until 10/01/2023 when the regulation changing from ADLs to Functional Abilities goes into effect. The retired ADL buttons can be removed after 10/01/2023.
- New CNA topics have features to help with the transition from section G ADL charting to section GG Functional Ability charting:
 - Pictures representing Functional Abilities have been added. Clicking on these pictures provides a definition of that functional ability.
 - Definitions have been added beneath each option for rating the resident's performance.
- Additional features include:
 - A more streamlined approach to charting these items, which should decrease time spent documenting. There are fewer topics to go into, and most abilities can be documented with a single click.
 - The topics are designed to fit on most monitors with little to no scrolling.
 - Each topic has the capability to document things like mobility devices, dental appliances, and additional cares provided by the CNA.
 - Bathing and Tub Shower Transfer have a topic separate from the other Functional Abilities. This makes it easier for users to identify when a bath/shower has been assigned. The type of bath and any additional cares can also be documented here.
 - 3+ Assist (Maine Only) is built into the topics and will prompt users to document any 3+ assist occurrences when "Dependent or 2+ Assist) is documented for any functional ability.
- ADLs, section G Charting for CNAs (if applicable):
 - ADLs have been combined into a single topic which is laid out in the same fashion as the functional ability topics for consistency.

New View Tasks/Reports

The following reports will be added with the 10.2.0.0 update. All reports will be available by choosing the green "Reports" button from the toolbar and then scrolling to the title of the report. All view tasks will be available by choosing the green "View" button from the toolbar, choosing residents, and then clicking "Tasks" from the menu at the top of the screen. If your facility uses Access Screens, links to the reports will be placed on access screens according to what it is listed beneath in the list below:

- MDS/RCC
 - View Task: Medication Review (High Risk Meds) This view task will display physician orders for medications listed in N0415, High-Risk Drug Classes: Use and Indication. Orders can be edited from this task.
 - Report: Medication Review (High Risk Meds) This report displays physician orders for medications listed in N0415, High-Risk Drug Classes: Use and Indication. This report can be run/printed for multiple residents at once.
 - GG Reports The following reports display documentation from Functional Abilities and Goals topics. They each contain 3 columns. One for CNA documentation, one for nursing/therapy documentation, and one that applies a formula to determine the response which is used most throughout the CNA, nursing, and therapy documentation to assist with determining the resident's usual performance.
 - Functional Abilities (GG) MOBILITY (v4)
 - Functional Abilities (GG) SELF CARE (v4)
 - Functional Abilities (GG) TRANSFERS (v4)
 - Functional Abilities (GG) BATHING (v4): This report allows users to highlight bathing performance and tub/shower transfers, however those items are also included in the self-care and transfer reports respectively.
- Pain Assessment Printable reports for Verbal and Visual pain scales are now available in the pain assessment to show residents when conducting the pain interview. These are located beneath the 0-10 and verbal pain scales within the assessment.
- CNA New incompletion reports are being provided, which are linked to new Functional Ability and ADL (if applicable) topics.

MDS Changes

- MDS printed and electronic forms have been updated with all new items, verbiage changes, and skip patterns from CMS.
- The Collect feature has previously pulled information from charting based on the Assessment Reference Date. It will now also pull information based on the admission or Medicare start date for applicable items.
- Section GG (GG0130 & GG0170) will now pull from both the Nursing/Therapy assessment and CNA charting and highlight the response that is most commonly documented among these topics.



- RAI excerpts for each item are available from withing the assessment by clicking the "?" in the upper right corner of the screen and then clicking the item number button. These excerpts have been updated to the latest version of the RAI manual.
- Clicking the item number button within an assessment displays the documentation from the lookback period for that item. The source for this documentation has been updated to include all new topics and words.
- Because of the significant number of changes which are effective on 10/01/2023, assessments which are opened with an ARD prior to 10/1/2023 cannot be changed to have an ARD after that date. Similarly, assessments with an ARD after 10/01/2023, cannot be changed to have an ARD prior to that date.
- The red text and green dots located throughout MDS assessments, signifying items included in quality measures and HIPPS/RUG calculations have been removed to prevent inaccuracies due to ongoing changes in regulations.
- Minor formatting changes to font and alignment have been made throughout the assessment forms.
- Buttons within section V have been updated to display the CAA number rather than being picklist (...) buttons.
